Data has become the lifeblood of organizations, powering insight into the latest business conditions, accelerating business decisions, driving better customer experience and powering new business models. Yet the task of ensuring that data is accessible, secure and well governed has never been more challenging. Data-generating applications are multiplying and moving into the cloud, self-service initiatives are opening up access to data to more users, and data lakes are now measured by the tens or hundreds of terabytes if not petabytes.

The good news is that metadata management vendors have emerged that can provide visibility into data and related assets—whether on-premises, in the cloud or spread across hybrid or even multicloud deployments—while also ensuring comprehensive data governance. Enterprise data catalogs have gained traction as the way to make data more visible to all users. Leading metadata management vendors also address data governance needs such as standardization of metadata, tracking of lineage, stewardship and enforcement of data policies.

The name of this ShortList has been changed from “Data Cataloging” to “Metadata Management, Data Cataloging

and Data Governance” to reflect today’s broader metadata management demands. IBM has been added to the list on the strength of IBM Watson Knowledge Catalog’s integration of catalog and governance capabilities as well as its growing adoption by customers. Waterline Data was dropped from the list. Constellation will monitor whether Hitachi Vantara, which acquired Waterline in Q1 2020, will step up the catalog product’s governance capabilities.

Threshold Criteria

Constellation considers the following criteria for these solutions:

- Find data and metadata across multiple sources products create a centralized reference index of data that is easily accessible to technical and business users
- Machine learning automatically discovers data assets and detects usage patterns
- Collaboration capabilities enables technical and business users to rate and review data assets, annotate what’s known about them and, if authorized, reject or modify tags and classifications
- Business glossary integration for users to better understand the definitions of data identified in the data catalog when glossaries are integrated or supported
- Supports and enhances data lineage, data governance, data access control, service-level and business rule insights, and enforcement capabilities
